Ensure you bring enough clothing to stay warm

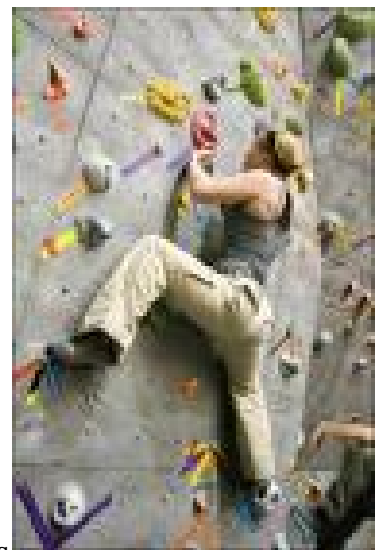
